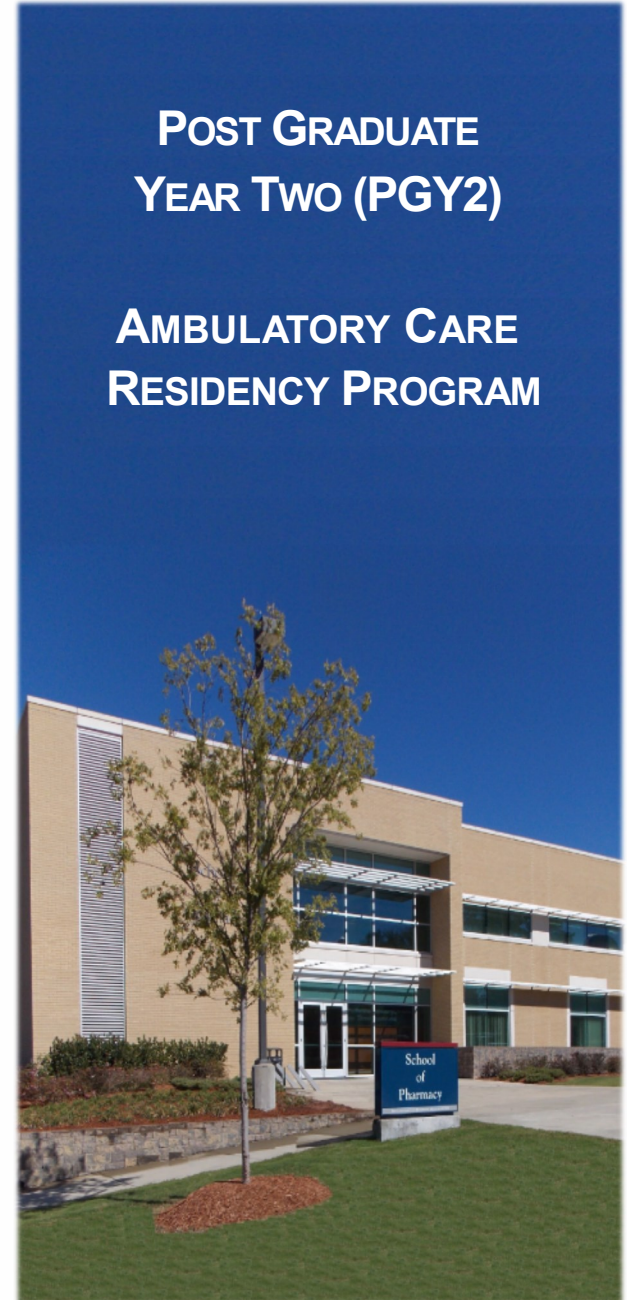

PROGRAM PURPOSE

The University of Mississippi offers a comprehensive post-graduate training experience with a PGY2 Ambulatory Care Residency Program. The program offers two positions based in the School of Pharmacy on the University of Mississippi Medical Center campus in Jackson, Mississippi. The program offers unique opportunities for precepting Doctor of Pharmacy students, PGY1 Community and Pharmacy Practice residents, and advanced clinical opportunities in a variety of practice settings. Preparing residents to become leaders in pharmacy practice is a strong emphasis. Research opportunities exist within the School of Pharmacy, the University of Mississippi Medical Center clinics, and with our external clinical partners. The resident will be exposed to a wide array of patients including insured, uninsured, and Medicare/Medicaid populations.

UNIVERSITY OF MISSISSIPPI MEDICAL CENTER LEARNING EXPERIENCES

Residents will have opportunities to learn in academic medical center based settings utilizing the EPIC system. These learning opportunities include Cardiometabolic, Family Medicine, Anticoagulation Clinics, Cystic Fibrosis, and many others based on the interests of the resident.

EXTERNAL CLINICAL LEARNING EXPERIENCES

Our external partners offer the residents opportunities in federally qualified health centers and private medical physician offices. Each of these learning experiences focus on chronic disease state management in a longitudinal manner.

TEACHING AND LEARNING CURRICULUM

Residents are provided the experience needed (including didactic lectures, problem-based learning group facilitation, academic committee service, and co-precepting students within clinical practice sites) to obtain an adjunct faculty preceptor position at an ambulatory care site or a non-tenure clinical track faculty position within a school of pharmacy. Completion of this curriculum will result in a Teaching Certificate.
